#### Pastor's Report

Dear brothers and sisters in our Lord Jesus, by the grace of our merciful Lord, we have endured such a traumatic year through our faith in Him in the midst of this worldwide pandemic which presently still has not relented. I cannot begin to really express my heart adequately to you as to your faithfulness to remain engaged in worshiping our Lord during these trying times. Every family has had to make decisions about safety balanced by the need for Christian fellowship, and how we are all longing for the day when we all may have assured confidence in the Lord that we may meet safely, trusting our Lord that the danger of the virus will have passed. Prayerfully by God's power, the vaccines will be blessed of Him to be effective to that end. This Pastor's Report covers this past year of Christian ministry, and especially the changes that have been made to offer the opportunity for every family to remain connected to our precious body of Christ here at Grace. It covers the past year January 1<sup>st</sup> – December 31<sup>st</sup>, 2020.

Concerning church ministry, even in the midst of such distress, both in nurture and in outreach, by the grace of God, He has seen us through! I desire in this report to thank the Lord for our continuing church ministries. These include Sunday school, Choir and Sunday morning worship, and our Wednesday evening Adult, Youth and Children's Ministries (which are now beginning in some capacities to function again - I have had a heavy heart as our Youth and Children's Ministries as well as our "We Are His" Drama Ministry have not been able to meet for such a long time). I am thankful to the Lord for all who are so committed to teach and to lead according to the will of God. I am so thankful as well for all who work very closely with me in administration, including our church's finances, weekly bulletin preparation, the bi-monthly newsletter (hoping to begin again soon), and the many office needs that are tended to throughout the year. The card ministry to our sick and shut-in and to remember birthdays and anniversaries is deeply appreciated. I rejoice in the Lord for those who have helped with our Food Pantry. Very sadly, our Pizza Ministry has been halted since the pandemic began. We will trust God's will going forward there when things are safe again. Additionally, what a great labor of love has been given by those who tend to our church's lawn care and who make our church sign changes and for those who keep the flowers under our church sign fresh and beautiful. May we all thank the Lord for His most merciful protection, and for our Safety Team that is committed to that end. May we also keep in prayer our Elder Board leadership, who truly watch over our church family spiritually.

Throughout the year, our "Hands of Grace" Ladies ministry has just been so servant faithful in helping families from our church family in bereavement with compassion. The money raised from the annual November Yard and Bake sale over two weekends helped a number of individuals and families meet needs in their homes.

Now before I attempt to share the monthly endeavors to serve the Lord which still did happen even in the midst of the pandemic, I must praise the Lord for the faith, heart, commitment and expertise of Kris Parker. Beginning in March through mid-June, Kris developed weekly recordings for Sunday morning worship with me and with small group special music and solos. Also during this time, many Wednesday evening Bible studies were recorded for our church family. While this was happening, Kris, along with the help of Rod Lee and Glenn Costello, began planning and then purchasing (with the Elder Board's blessing) the equipment we would need to present an effective Livestream in our sanctuary for the sake of our families staying home for safety reasons that they could watch and could worship our Lord Jesus Christ, His Father's Son! The time commitment by itself was immense. But through Christlike perseverance and love, our Livestream is up and running, and is a tremendous blessing to all who are taking advantage of this outreaching grace of Since the pandemic began, only once did we not have a recorded or God. Livestreamed service of worship, and that because of a sickness in the Murdoch family. Thank you all for obeying the Lord's call and using your Holy Spirit inspired gifts for His glory and for our needed edification!

In January, our "We Are His" Drama Ministry shared at Pleasant Grove Baptist Church. Our annual church members meeting was held, with much thanksgiving unto our Lord for His continual mercies to us all! Our Youth-sponsored Winter Retreat was held at High Pastures Christian Retreat Center in Burnsville, North Carolina. The DVD, "Overcomer" was shown, and the Lord touched and challenged us all to a deeper faith in Him. The time of gift-giving and the "Peace Candle" sharing was such a time of blessing from the Lord. We were very excited to meet Joe and McKenzie Buonaiuto and to have them share God's call to their lives in missions!

In February, our Men's Christian Fellowship sponsored Valentine's Dinner for the ladies of our church was a precious evening together. Rev. Myra Pearson brought the message from God's word to encourage us all. A wedding shower was held by our "Hands of Grace" Ladies Ministry for Trey Parker and Jennifer Melton. Our "We Are His" Drama Ministry shared at Second Baptist Church in Manning.

In March, our "Hands of Grace" Ladies ministry held a bake sale to raise funds for ministry projects. They also held two wedding showers for Ken Parker and Mary Webb Adams and Stanley Williams and Emelda Abongnwi. Stan and Emelda were married on March 19<sup>th</sup> at the home of Yogi and Faye Johnson's just before the heavy Covid-19 restrictions began. Our "We Are His" Drama Ministry shared at Jehovah-Jirah Outreach Ministries. After our church met for worship on March 15<sup>th</sup>, the schools closed in-person because of Covid-19, and we did as well. The Nicavangelists were scheduled to share at our church on March 22<sup>nd</sup>. They came and stayed at our church for three days, and still shared their presentation outside on our church property on David's victory from the Lord against Goliath. It was amazing! It can still be seen on their website, as Claire and I were the only ones from our church to see their presentation live. The next Saturday began our recordings for worship from March 29<sup>th</sup> until our first time back in worship on Father's Day, June 21<sup>st</sup>.

Therefore, April through late June for Sunday morning worship and Wednesday evening Bible study happened through recordings done by Kris Parker. We celebrated Resurrection Sunday in April and Mother's Day in May. During this time, Ken Parker and Mary Webb Adams were married on May  $23^{rd}$ . Then, Trey Parker and Jennifer Melton were married on June  $13^{th}$ . In-person worship with the Livestream began on Father's Day, June  $21^{st}$ . In-person Bible study for our adults with the Livestream began shortly thereafter. These services continued throughout most of July, and have continued throughout the remainder of 2020.

In August, Hannah Moore (Francis Marion University) and Janette Murdoch (Lander University) were honored for their college degree accomplishments.

In September, our church family began taking steps to restart some of our Christian ministries, as our Choir restarted as well as our "Hands of Grace" Ladies meetings focused on preparations for the November fundraiser. On September 6<sup>th</sup>, we had 9 new members join our church family by faith through our Lord Jesus Christ—some in-person and some over the Livestream, which has been wonderful!

In October, there was a painting day for the ladies of our church. We also had a very needed cleaning day throughout the three wings of our church, which went very well! Finally, we restarted our church bulletin distribution to our church family for in-person Sunday morning worship.

In November, our "Hands Of Grace" Ladies Ministry held two weekends of a Yard and Bake sale for our community which helped many families meet needs. The

amount raised over the two weekends was about \$3,250.00, for which we all give our Lord praise! Also, it was decided by our Elder Board that in-person Sunday school and in-person Children's Church would restart in the month of December, for which many are excited for these restarts.

In December, we followed through with the restarts of Sunday school and Children's Church, which is going well! We celebrated Christmas in worship during our Advent Sundays to welcome in the birth of our Lord Jesus Christ! We are so thankful to the Lord for seeing us through 2020, with our humble prayer that 2021 will be much healthier and holier until our Lord Jesus comes again!

Now, please allow me to share with you concerning our church membership. Our church membership going into this year was 148. In the past year, we had 9 dear souls who joined our church family in membership, with 1 of them baptized. We did have 5 dear souls pass into the arms of our Lord (Deborah Ard, Patricia Hildebrand, Thomasyne S. Martin, Jim Nicholas and Curt Walters). We also had 1 resignation, 4 removed by the authority of our Elder Board and 2 transfers to another church. Thus, our membership roll currently stands at 145. We did have 1 church transfer from our Dedication Roll. Thus, our present Dedication Roll currently stands at 8. Not noticeable in these numbers are individuals and families who attend our church regularly but have not yet taken the step to join our church family in membership. Whether they ever do or do not, we are so grateful that they are serving the Lord with us!

#### **Budget Explanation**

As you read the following information concerning our 2021 budget, those line items with percentage increases or decreases will be explained, along with anything else where it is felt an explanation is needed.

Concerning Staff Salaries, they have remained the same for 2021, except for our pianist salaries, which have been reduced as we are largely now using recorded instrumental arrangements that play in harmony with each hymn in our church hymnal. Our church secretary has volunteered her salary again for this coming year...something she has done since 2008. Thank you, Sylvia. Also, Pastor Mike's reimbursable expenses have been decreased by \$1,000 (20%), assuming that his travel will still be limited for at least the first few months in 2021. For the same reason, the Childcare budget has been reduced by 55%.

Concerning Church Ministry, we have two decreases for 2021. The first of these is in Missions, where we are no longer supporting the Jordan Crossroads Ministry Center. The second is in the category of Supply and Restock, where our need for kitchen supplies for church family Christian fellowship continues to be curtailed because of the pandemic. All other ministries remain at their current funding.

Concerning our Building Needs, we have three increases for 2021. The first is our Property Insurance which has gone up slightly. Our water bill has also gone up slightly. Our telephone/internet bill has increased by 30% so our internet speed could be increased to support our Livestream, which it has (no buffering)! All other church building needs have remained at their current funding.

Concerning our church loan, we refinanced our church loan from 4.5% to 3.5% for the final five years of our church loan. Our principal payment each month should be between \$3,150-\$3,200. This is about 84% of the total payment of \$3,750. It is expected that we should finish the remaining \$197,000 of our church debt sometime in the second half of 2025 (less than five years from now)! I hope you are as excited about this as I am!

Overall, our church budget for 2021 is slightly lower than it was in 2020. The amount needed for 2021 will be \$3,162 weekly. Please pray that our tithes and offerings may grow so that our church family can do even more in serving our Lord!
